#### I. <u>Questions and Answers:</u>

- Q1. What is the maximum file size allowed for electronic submissions?
- A1. 20 MB.
- Q2. How old is the TSA Explosives Detection System (EDS) equipment?
- A2. The equipment was installed in 2012.
- Q3. Will the TSA equipment be a part of this scope?
- A3. We anticipate relocating the TSA equipment to be a part of the scope.
- Q4. **Section A-5 a & b**: This section requests the respondent's "Class A Virginia Contractor No.\_\_\_\_\_." Should this be revised to request the firm's SCC No. or firm APELSCIDLA No. Issued by the VA. Department of Professional & Occupational Regulation?
- A4. Yes, **Section A-5 a & b** shall require the Offeror to submit their VA SCC No. rather than Class A Virginia Contractor No.
- Q5. **Section B-9**: Is a SWaM certificate holder considered compliant and contributing toward the DBE goal?
- A5. No, SWaM certifications are a state level certificate where the DBE requirements are for federal level certificates.
