The Roanoke Regional Airport Commission met in the Airport Conference Room, Second Floor of the Terminal Building on Tuesday, May 17, 2022, at 8:30 a.m. Mr. Guidry, Chair, presided.

## **MINUTES**

The minutes of the regular monthly meeting held on May 17, 2022 were before the body.

Dr. Bishop made a motion that the reading of the minutes be dispensed with and approved as recorded. The motion was seconded by Ms. Lawrence and unanimously approved.

#### COMMENTS BY THE EXECUTIVE DIRECTOR

Mr. Stewart recognized staffing changes; Ernie DiDonato, Amanda DeHaven and Gary Ruby have all recently retired from RRAC. Rebecca Wilkins-Huffman will be retiring at the end of July. Sandra Newman has been promoted to Access and ID Manager and Justin Snead has been promoted to an Airport Operations Officer. Additionally, there are currently several positions open, Operations Officer, Maintenance Technician, Police Officer and Assistant Director of Finance.

Mr. Stewart and Mr. Kotchou attended the Virginia Airport Operators Conference Spring Workshop in May. Topics of discussion included briefings by VA Airports on unique projects and challenges, Cyber Security at Airports, VAOC Legislative issues, an update from FAA Washington ADO, and the VAB Meeting.

At the Roanoke Valley Transportation Planning Organization Policy Board meeting on May 26<sup>th</sup> a resolution approving Amendment to the FY 2021-2024 Transportation Improvement Program. This includes Roanoke County CORTRAN Services for seniors and people with disabilities.

Mr. Stewart congratulated the entire ROA team, in particular Airport Operations, Public Safety and Maintenance for successfully passing our annual certification inspection with no significant findings and only a couple of minor ones which were resolved on the spot.

Mr. Stewart reminded the Commissioners of the Air Service Development RFP that is currently active and the Fixed Base Operator Lease and Operating Agreement that will be issued in the coming days.

Load factors have been heavy with local graduations, Ironman and summer travel. Mr. Boettcher met with several airlines in Reno last week at the ACI Jumpstart Conference, he will provide an update following the Financial Report.

Tailwind Concessions purchased Air Host/ Varona and we continue to work with them to amend our contract to reflect the assignment and to properly include ACDBE participation, but in the interim they have begun to make improvements.

Mr. Stewart spoke to the benefits of joint meetings with each municipality; Roanoke City, Roanoke County, Salem and Botetourt. These meetings will be planned in the upcoming months.

And lastly, Mr. Stewart presented the Commissioners with the idea of formalizing Juneteenth as a holiday on the Commission calendar. A formal resolution will be brought before the group in July.

The monthly financial report for the eleven months ended May 2022 was presented by the Director of Finance.
